SUITABLE EXTINGUISHING EQUIPMENT

Extinguishing substances are: carbon dioxide and chemical powder. For product loss or leakage that has not caught fire, water spray can be used to disperse flammable vapours and protect those trying to stem the leak.

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

GENERAL INFORMATION

In the case of fire, use jets of water to cool the containers to prevent the risk of explosions (product decomposition and excess pressure) and the development of substances potentially hazardous for health.
